Chairperson's Foreword

It gives me great pleasure to present this year's Annual Report of the Confederation of Community Groups.

We have now completed the second year of our three year Strategic Plan and I am delighted to report that we continue to deliver quality programmes and services despite operating in challenging circumstances. Ongoing cuts to public expenditure, systemic political uncertainty, restructuring of local government and the burden of ever increasing governance ensures that requests for our services are constantly increasing while our funding is being constrained.

As is evident in this report we have been able to sustain the level and quality of our service delivery to local communities in relation to capacity building & support, community education & engagement and improving governance and social infrastructure. We have also continued to advocate on behalf of the wider community & voluntary sector in our role as a sub-regional network; to develop and improve partnership working and to upgrade our Ballybot House premises for the benefit of our tenants, staff and service users.

We were able to retain core funding from the Department for Communities (DfC), Newry, Mourne & Down District Council (NM&DDC) and from the Southern Health & Social Care Trust (SHSCT). To the DfC, NM&DDC and SHSCT I offer my sincere thanks. Core funding remains essential for project delivery and contributes towards the sustainability of the Confederation.

During the year we lost two members of staff; Noel Mc Cluskey retired from the post of Caretaker after more than 15 years of service and Niall Mc Cluskey resigned his Assistant Caretaker post to undertake a career change with a local company. To both I would like to express our gratitude and acknowledge their contribution to the Confederation.

Diane Cowan (Vice Chair) has recently advised that she is no longer able to commit her services to the Board due to personal circumstances. I would like to record our sincere thanks to Diane for all her help and wish her well for the future. Following last year's AGM we welcomed two new Board members - Anne Woods (Cedar Foundation) and Deirdre Shields (Newry Gateway Club) who I feel have both complemented and helped strengthen a diverse and professional Board.

Finally, I would like to personally thank my fellow Board members, staff and volunteers and the membership for all their support and co-operation throughout the year. Thanks are also due to our many funders who provide the vital financial support necessary for our work. We look forward to developing relationships with them and all our stakeholders as we renew our commitment to play a leading role in the development of our local communities.

Chief Executive's Report

As expected, the last twelve months have been challenging given the uncertainty in funding, political instability and the tough economic conditions faced. However I am delighted to report that we busied ourselves and were able to meet our strategic aims and objectives by delivering quality projects and services designed to meet ever increasing demands.

Whilst service delivery, focussed on the needs of our users, is at the heart of our work we were able to significantly contribute to social policy development by representation on strategic partnerships, by participating in seminars/conferences and by responding to consultations throughout the period. At regional and policy level we continue to work in partnership with colleagues Community Development Network Forum and Community Places and have responded to consultations such as "Protect Life Suicide Prevention", Dfl's "Programme for Government" DfC's "Strategic Support to Volunteering" and to NMDDC's "Community Plan". We have also contributed extensive time to the Strategic Stakeholders Forum and to the new structures established to strengthen engagement with the com/vol sector in the evolving community planning process.

Local delivery is evidenced in the report through our work in the Neighbourhood Renewal Programme, Community Work & Education and in our Older Peoples and Volunteering Programmes. Governance, volunteer management and policy development was delivered through 29 community development courses and 50 of our volunteer students achieved their Millennium Volunteer Award. We were able to provide additional training to 40 of our older volunteers at our Dromantine away day and to celebrate with 450 community volunteers at our annual "Shining Light" awards event.


We continued to work in partnership with local communities, with funders and with our colleagues in the sector in programmes such as Home Secured, Good Morning, Good Neighbour, with the Wellbeing Action Partnership, Travellers Forum and Age Friendly Initiative and we were delighted to attract longer term funding from HSCB for an outbound telephone support service for older carers .We have also been able to support groups with Charity registration and reporting, compliance, training, operational plans and sourcing of funds.

We completed the upgrade of our Volunteer Support Centre and refurbishment of large areas of our Ballybot House premises whilst at the same time reducing expenditure. We continued to provide flexible low cost office accommodation, day care, venue hire and back-office support to our tenants and the wider community & voluntary sector resulting in generated income equating to approximately 44% of total income.

In conclusion I would sincerely like to thank all of the staff, volunteers and board members for their dedication and commitment over the past year.



Good Morning Service





 20 minutes to those 177 service users, their families and support workers. This approximates (@ an average 10 minutes per call) to some 5,351 volunteer hours to date spent talking directly to older people and supporting their needs.

Good Neighbour Service

During the year 2016/17 period the Good Neighbour service was provided for a total of 84 service users. The service provided on average 1 visit per client per week by

our pool of 71 Good Neighbour



volunteers. This equates to approximately 6, 552 voluntary hours (@an average 1.5 hours per visit) spent this year by volunteers providing face to face support for older people and helping them to live more independently. 53 of our Good Neighbour volunteers are themselves in the 50+ age bracket.


This project, which has proven immensely popular with older people who are feeling isolated and vulnerable, is delivered by a team of dedicated CCG volunteers working throughout the

Launch of Good Day / Good Carer Service

September 2016 saw the launch of the CCG's new Outbound

Telephone Support Service for Older Carers along with the official opening of our new Volunteer Support Centre.

Speaking at the launch, Mrs. Gillian

Fitzpatrick, Chair of Newry,
Mourne & Down District Council,
told those in attendance that the
Council was particularly proud of
the strong volunteering ethos of
the area and she noted that this ethos

was evident in all aspects of the CCG's work.



Also in attendance was Mr. Eddie Lynch, Commissioner for Older People for N. Ireland, who said

"as Commissioner for older people for Northern Ireland, I am only too happy to be here today to see how this new centre will positively impact on the lives of older people in Newry and the surrounding areas. The outreach work carried out through the older people's programme is vital to the wellbeing of the older people who use this type of service. Too often we hear about older people who are lonely, socially isolated and have limited contact with family, friends and neighbours. We need to ensure



we are an age friendly society, encouraging, supporting and welcoming older people into every activity in our communities."

Outlining the CCG's contribution to providing services for older people Mr. Raymond Jackson, CCG's CEO, paid tribute to the CCG staff and 110 volunteers involved with the CCG's Older People's Community Project. He then thanked The Wolfson Foundation for its £17k Capital Funding, the CCG Board for its match funding and all the other funders who contribute to the programme's revenue costs (SHSCT, HSCB, and PCSP).

Good Day / Good Carer – a successful first year



Within the first seven months of the project Good Day / Good Carer volunteers made a total of 2,357 which at an average of 15 minutes per calls this equates to 590 volunteer hours spent engaging with and supporting older carers. During the period older carers were made aware of 188 events /initiatives pertinent to their caring role. Of the 113 older carers engaged in this Out-Bound Telephone Service 63 carers received a Carers Assessment through the Southern Health & Social Care Trust. A total of 51 older carers were signposted for

additional support services.



Community Training & Education Programmes



During the year 307 people completed training courses with the CCG as part of their community projects. In total CCG delivered 29 courses for community groups and CCG volunteers which included:

Schools Annual Summer scheme for children with a disability

A total of 23 students delivered a summer scheme for children with a disability to 12 families in July / August 2016. The families were referred by the Southern Health & Care Trust's Children's Disability Team. Additionally some students were matched to volunteer roles providing day care support for adults with physical & learning disabilities. All student volunteers received their Millennium Volunteers Certificate of Achievement.



Schools Volunteering Programme

A total of 27 students were recruited and placed on the Schools Volunteer Programme in Feb/Mar 2017. The 8 week programme was delivered to older people and adults with learning disabilities under the Southern Health & Care Trust's Supported Living Scheme. The project provided the young people with high quality volunteering opportunities in the field of social care. All student volunteers received the Millennium Volunteers Certificate of Achievement.

Volunteers Annual Training Day

Our annual Away Day for OPCP volunteers was held at Dromantine conference centre on Thursday 25th February 2017 with over 40 volunteers in attendance. The day, which was enjoyed by all who attended, provided an opportunity for volunteers to learn about each other's experiences of volunteering while undertaking training relevant to the project in which they are involved.





CCG Partnership Working



NM&DDC Travellers' Forum

During the year CCG worked with a range of partners on the NMDDC Travellers' Forum to develop ways to engage with the local Traveller community. NM&DDC commissioned a



study of the Community Development needs of the Traveller community in the Council area. The subsequent report identified the CCG as potentially one of the main partners in this

future work. CCG is currently developing proposals for the support of Travellers in line with the Forum's report and will be seeking partners to join us in this work.



Community Planning & Engagement

CCG Board and staff attended a wide range of meetings in relation to Community Planning & Engagement including the Strategic Stakeholders Forum, Thematic Groups and the Strategic Community Planning Partnership Board. CCG Board/Staff/Members also attended DEA Forum meetings for the Newry, Slieve Gullion and Crotlieve areas. For the Newry DEA Forum CCG acted as the community and voluntary sector representative while CCG affiliated groups (Tí Chulainn and Drumgath Women's Group) were approved as members to Slieve Gullion and Crotlieve DEA Forums respectively. CCG staff also attended workshop presentations on Health & Wellbeing, Environmental & Spatial Development and Economic Development.

Facilitating Community Development in Ballybot House




In April CCG facilitated a visit to Ballybot House from First Steps Women's Group based in Dungannon and in May we hosted a joint delegation from Louth County Council / Louth Community Collective to explore the management/development of a model social enterprise.

Later in September we hosted MP Kris Hopkins (Junior Minister NIO) and provided an overview of the challenges, threats and opportunities to and for Community Development Network organisations and to the wider community and voluntary sector. In October we facilitated a visit to Ballybot House for a group from Armagh requested by Steven Fields on the management/development of a model social enterprise.



Total income was £578,068 for the year ended 31st March 2017 which was £4,785 less than that of the comparative figure (£582,853) for the period ended 31st March 2016. Although we received £17000 Capital funding there was a reduction in Revenue funding from both Generated income and Grant income (relating mainly to management fees and the cessation of a number of projects respectively).



We were able to reduce expenditure on the Ballybot House & An Stóras premises while at the same time completing the upgrade of our Volunteer Support Centre, repainting large areas of the property and replacing significant areas of carpet throughout. A warmer winter combined with energy efficiency savings helped to reduce our Heat & Light bills by £2,894 whilst at the same time reducing our carbon footprint. We were also able to restrict all other non-essential spend resulting in a positive cash-flow throughout the period without the need to seek any loan or overdraft facilities.

Income streams derived from office and day-care accommodation, venue hire, back office support and resource centre equated to almost 44% of total income with surplus income used to offset deficits within the General Management Account and Neighbourhood Renewal Project. Throughout the period CCG staff made significant efforts to secure and retain funding from a range of funding bodies (as listed below) and we were delighted to secure 3 years funding from HSCB for a Carers Outbound Telephone Support Service.

Despite the significant contributions made towards long term sustainability, the continuing support in the form of core funding from DfC (Community Investment Fund), NM&DDC (Community/Voluntary Service Level Agreement) and SHSCT (Older Peoples Programme) has been, and will continue to be, essential in supporting CCG to deliver its varied projects and activities in the challenging financial times ahead.

The Finance & Services team continue to discharge their duties in strict accordance with accounting policies and our audit has been prepared in line with the provisions of the Companies Act 2006 and the Statement of Recommended Practice (SORP) "Accounting & Reporting by Charities". We are again pleased to advise that our Financial and Governance Controls are deemed as "Robust" (this is the lowest risk status as certified by the DfC's Voluntary & Community Unit).



Conference, Retail, Day-Care and Office Accommodation at Ballybot House & An Stóras


Retail, day-care and office accommodation remained a vital source of income throughout the year and Ballybot House meeting and conference facilities continue to be a popular choice for a wide range of organisations. Income was boosted by a £17,000 Capital Grant received from The Wolfson Foundation which offset a reduction of £5,211 in room hire and refreshments/catering income.

During the period we were sad to lose tenants People First, Clanrye Developments and Relate. We were delighted however to attract Praxis and the Federation of Family Practices as tenants in June 2016 and January 2017 respectively and to offer additional accommodation to Citizens Advice Newry & Mourne and Community Restorative Justice. We continued to use all available space for our own programmes, for storage and for additional venue hire facilities again securing 90% occupancy within Ballybot House and 100% within An Stóras throughout the period.

Additional Services Provided:

Our Finance & Services team continues to provide administrative and "back office" support to CCG Projects, to affiliated members and to external bodies. Some of the services provided by our staff include:

- Help to establish financial systems & applications for funding;
- Assistance with salaries and wages;
- Advice on recruitment & selection procedures;
- Guidance on charitable law & constitutions;
- Charity Commission Registration and Reporting;
- Top of the range conference & meeting facilities;
- Compliance with funding & legal requirements and computation of claims information;
- Compliance with Health & Safety Legislation and Risk Assessments;
- Resource Centre operations printing, copying, booklets, binding, reprographic services, fax, e-mail, internet etc.
