## **CHIEF EXECUTIVE'S REPORT**

Given that 2017/18 saw the completion of our 2015-2018 Strategic Plan I am delighted to report that we were able to meet our strategic aims and objectives by delivering quality projects and services designed to meet an ever increasing demand.

Local delivery is evidenced in the report through our work in the Neighbourhood Renewal Programme, Community Work & Education and in our Older Peoples and Volunteering Programmes. We were able to provide additional training to 60 of our volunteers and to celebrate with 500 community volunteers at our annual "Shining Light" awards event.

We contributed to social policy development by representation on strategic partnerships, by participating in seminars/conferences and by responding to consultations. We also committed ourselves to the new structures established to strengthen engagement with the community & voluntary sector in the community planning process. We continued to work with local communities, with funders and with our colleagues in the sector in a varied range of programmes (listed in the report) and were able to support groups with Charity registration and reporting, compliance, training, operational plans and sourcing of funds.

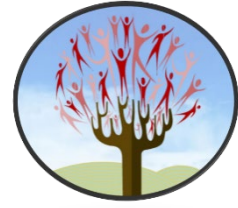
We completed the upgrade of our IT system whilst at the same time restricting non-essential expenditure. We continued to provide affordable office accommodation, day care, venue hire and back-office support resulting in generated income equating to approximately 50% of total income.

## **Supporting Community Development & Local Volunteering**



This year as part of the Neighbourhood Renewal programme the CCG continued its support to all Community Associations in the Newry Neighbourhood Renewal area. One of our main areas of work this year has been the review of the groups' Child Protection policies. This was successfully completed and CCG staff are now working with individual groups to assist them in dealing with issues such as bullying and internet safety.

Additionally, we worked with a range of other Community and voluntary groups in the Newry area in sustaining and developing a community infrastructure that can meet the needs of all the local communities. 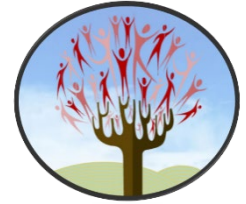
### **Ethnic Minorities & Irish Travellers**

CCG attended meetings of the NMDDC Travellers' Forum and met with staff from the Big Lottery with a view to progressing an application for a pilot programme to enable a full application under the Lottery's "People in the Lead" theme. This work is ongoing.

Throughout the year CCG have worked steadily with the local Polish community to establish what is now called the Polish Families Community Association. The CCG has guided the group through all of the formation stages and this year they registered with the Charity Commission as a charity and successfully applied to the John Moores Foundation to cover their first year's core costs.

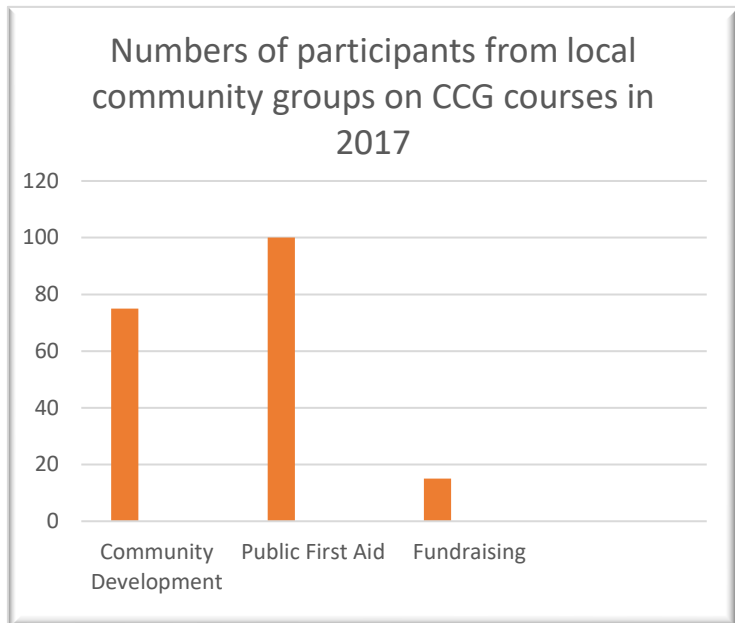


### CCG Training Courses in 2017

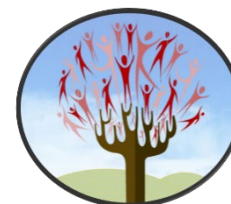

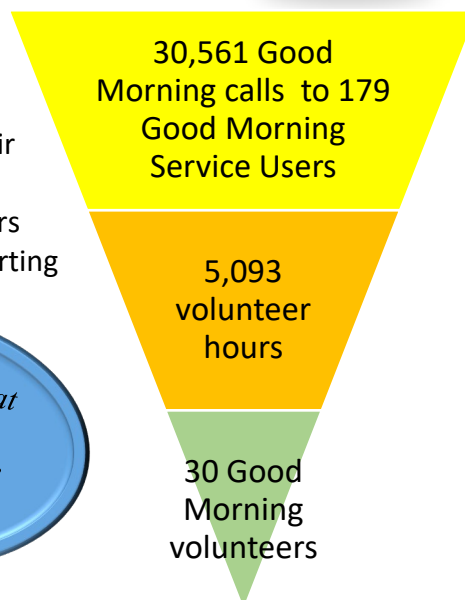


## Older People's Community Projects



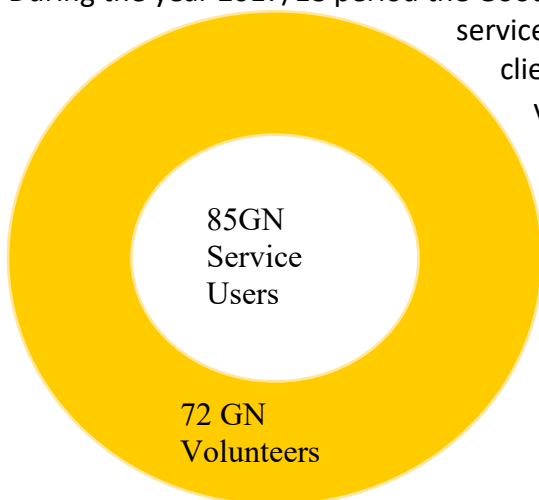
### Good Morning Service

In the year 2017/18 the Good Morning service was provided for a total of 179 regular service users. The service made a total of 30,561 Good Morning calls ranging in duration from 5 – 20 minutes to those 179 service users, their families and support workers. This approximates (at an average of 10 minutes per call) to some 5,093 volunteer hours to date spent in talking directly to older people and in supporting their needs.



### Good Neighbour Service

During the year 2017/18 period the Good Neighbour service was provided for a total of 85 service users. The service provided on average 1 visit per client per week by our pool of 72 Good Neighbour volunteers. This equates to approximately to 6,708 voluntary hours (at an average of 1.5 hours per visit) spent this year by volunteers in providing face to face support for older people, helping them to live more independently. 54 of our GN volunteers are themselves in the 50+ bracket.



### Good Day / Good Carer Service

Good Day Good Carer is a confidential telephone support service for older carers offering ongoing support and a listening ear. This service provides information and advice and signposting to other services. The service is manned by ten trained and dedicated volunteers who provide a weekly or monthly call to 140 carers in the community.



## Older People's Community Projects



### Home Secured Project

The Home Secured scheme provides security devices to older more vulnerable people who have been the victim of a crime or those living in fear of crime. The service is run by seven volunteers across the Newry Mourne and Down council area providing and fitting a range of locks, alarms and lighting. This year the scheme's volunteers fitted some 4,090 devices. The range and number of devices are outlined in the accompanying Fig 1.

### 2017 / 18 CCG Student Volunteering Programmes

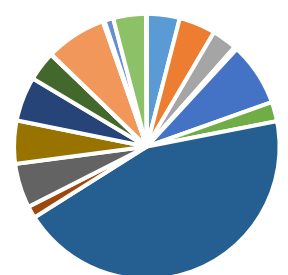
During June, July and August 2017 as part for our annual Student Summer Scheme, in partnership with the Southern Health & Social Care Trust, we recruited and placed 36 volunteers with 15 families of children with a learning disability. All of the 36 young volunteers also participated in a 3-day induction training programme delivered by the CCG where they learned about:

- Principles of Good Care

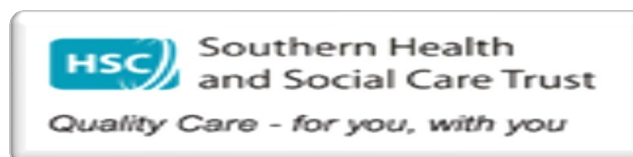

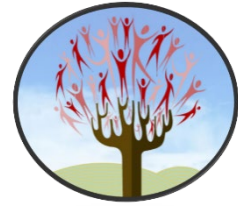

## CCG Partnership Working



### DHH Pathfinder Group

In September CCG responded to a SHSCT/PHA community consultation regarding Daisy Hill Hospital (DHH) Emergency Department and attended a related Community Forum meeting.

Following on from this CCG staff facilitated a further community /voluntary sector meeting, sourced nominations from the sector to sit on the DHH Pathfinder Group and sub-groups and provided recommendations to Dr Anne Marie Telford (DHHPG Chair). CCG hosted a follow up Community Forum in relation to the Daisy Hill Hospital Pathfinder Group in November and continue to provide support to the Group

### Fresh Start – Women in Community Transformation (WICT)

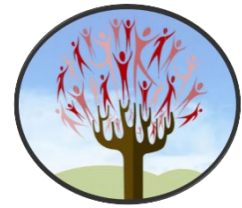
In May 2017 CCG promoted and hosted a DfC / DoJ stakeholder early engagement event at Ballybot House for a future Women's Programme under the Fresh Start Agreement. The programme was officially launched later in the year and CCG facilitated meetings with Co-operation Ireland for the Women in Community Transformation programme (WICT) initiative at Ballybot House on 13<sup>th</sup> December and 24<sup>th</sup> January. CCG is currently assisting Co-operation Ireland in delivery of the programme at local level.

### Economic Development

CCG attended Newry Chamber of Commerce & Trade Board meetings and sub group meetings throughout the year and assisted at their EGM (June 17) at which our recommended new Articles of Association were adopted. We continue to attend Commerce & Trade Council meetings and took part in a Brexit meeting at Town Hall in Feb 18. We also attended the quarterly "Greater Newry Vision Partnership" meetings (hosting a number of these at BBH).



## **CCG Partnership Working**



### **Economic Development contd;**

We continue to partner NMDDC and have attended regular “Purple Flag” meetings which is a body set up to secure international accreditation and promotion of Newry City’s Night time economy. We met with the new NIO Minister and Undersecretary of State (Lord Borne) at BBH in July 17 during a visit to Newry. CCG staff were able to provide him with an update on Community Development in the local area, core funding, issues affecting the community & voluntary sector and Brexit implications.

### **Community Places NI / Community Transport**

We attended Board meetings of Community Places who provide independent advice and support to individuals and groups in relation to planning, engagement and community planning. We also attended Newry & Mourne Community Transport Board meetings and Transport stakeholders meetings in Dungannon and Craigavon (July 17) re Integrated Transport Strategy

### **Health & Wellbeing:**

We co-chaired the Wellbeing in Action Partnership (WAP) throughout the period at various venues and organised and facilitated Homelessness sub-group meetings at BBH in Dec 17 and Jan 18. These meetings included members from community & voluntary sector, NMDDC, MLAs and Member of Parliament. Further outreach was made to the Polish consul, Salvation Army, BIDS, NIHE and Newry Chamber of Commerce & Trade. Leading on from this we were asked to join a

newly formed NIHE

“Locality Group” tackling homelessness in Newry (First meeting held Jan 18). A street count of homeless people was undertaken (March 18). NMDDC have also formed a Housing Symposium to address lack of social and affordable housing.

### **Neighbourhood Renewal (NR)**

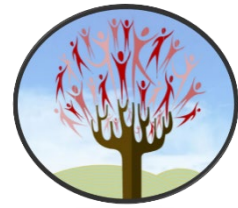
We continue to act as Lead Partner for NMDDC in delivering the Capacity Building & Support element of this programme to nine Community Associations in the Newry city area. CCG staff attended bi-monthly NR Partnership meetings, monthly sub group meetings, Action Planning days and Fund Raising events throughout the period and met with the NR coordinator in May 17 to discuss an exit / continuation strategy for the programme.

### **Community Planning & Engagement:**

CCG Board & staff attended the quarterly Community & Voluntary Strategic Stakeholders and Newry City DEA Forum throughout the period and also attended a Community Planning Workshop in Newcastle (Sep 17) to promote greater connectivity between DEAs and Thematic Groups. We attended the launch of the NMDDC Community Plan and Delivery Plans in Downpatrick (In Oct 17). CCG submitted recommendations for NMDDC’s strategic actions and “Health & Wellbeing” draft templates, and provided further recommendations for NMDDC “Performance Improvement”. CCG conducted an on-line survey of community and voluntary groups in Crotlieve, Newry and Slieve Gullion DEAs.

### **Seminars & Consultations**

CCG hosted / attended the following seminars:

- In collaboration with CDHN and the NI Human Rights Consortium hosted a seminar at BBH in September 17 focusing on Brexit and its potential effects on Human Rights. The seminar was well attended by many small organisations including representatives of the Polish Families Community Association.
- A joint HSCB / SHSCT “Procurement Awareness” seminar at NMEA in May 17 to discuss changes to procurement / SLA delivery and E tendering.
- A PHA consultation & workshop in Nov 17 in relation to the development of a Framework to support Community Development initiatives.
- Met with staff from the NI Council for Integrated Education in Nov 17 and facilitated them to make a presentation to the NMDDC Newry DEA Community Forum in February 2018.
- Hosted a Universal Credit Training seminar at Ballybot House in January 2018 in partnership with CAB. We intend to provide on-line facilities for claimant’s registration and applications while CAB provide advice and support.
- Submitted a response to DfI’s consultation on minibus driver’s licence and section 10B permits in Nov 17.
- Engagement event and further response to DfI’s consultation relating to the proposals for Newry southern relief road in December 2017.
- Hosted a consultation with Andy Hall (Big Lottery) in January 2018 in relation to future BIG Lottery Funding of local groups.
- Seminar on Participative Budgeting which was co-facilitated by Community Places and NMDDC in March 2018.

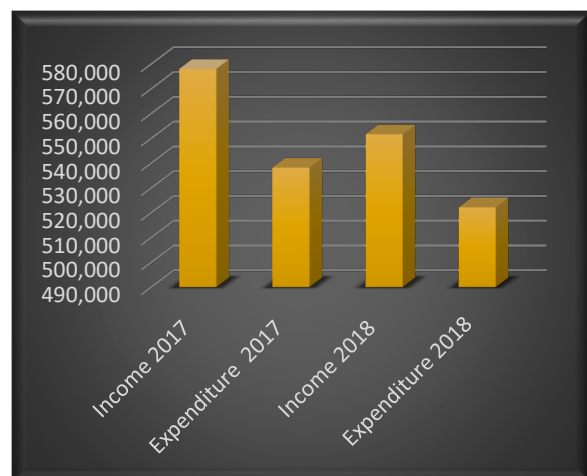


## Finance & Services

### Finance

Total income for the year ended 31<sup>st</sup> March 2018 was £551,662 which was £26,406 less than that of the comparative figure (£578,068) for the period ended 31<sup>st</sup> March 2017. There was a reduction in Revenue funding from both Generated income and Grant income (relating mainly to Room Hire, Refreshment & Catering and the completion of Reach programme and capital programme respectively).

Total Expenditure reduced from £538,220 last year to £522,153 in this period resulting in an overall surplus of £29,509. We were able to reduce expenditure on our Ballybot House & An Stóras premises while at the same time completing the upgrade of our IT equipment. All non-essential expenditure was restricted resulting in a positive cash-flow throughout the period without the need to seek any loan or overdraft facilities.



Income streams derived from office and day-care accommodation, venue hire, back office support and resource centre equated to 50% of total income with surplus income used to offset deficits within the General Management Account and Neighbourhood Renewal Project. Despite the significant contributions made towards long term sustainability the continuing support in the form of core funding from DfC (Community Investment Fund), NMDDC (Community & Voluntary Service Level Agreement) and SHSCT (Older Peoples Programme) has been, and will continue to be, essential in supporting CCG to deliver its varied projects and activities in the challenging financial times ahead.

The Finance & Services team continue to discharge their duties in strict accordance with accounting policies and our audit has been prepared in line with the provisions of the Companies Act 2006 and the Statement of Recommended Practice (SORP) "Accounting & Reporting by Charities". Our Financial and Governance Controls continue to be deemed "Robust" (this is the lowest risk status as certified by the DfC's Voluntary & Community Unit).

### Conference, Retail, Day-care and Office Accommodation at Ballybot House & An Stóras

Retail, Day-care, Office accommodation, Venue Hire and Conference facilities remained a vital source of income throughout the year. We were delighted to attract P.J. Toal (Counsellor) in January 2018 and continued to use all available space for our own programmes, for storage and for additional venue hire facilities securing 90% occupancy within BBH and 100% within An Stóras throughout the period.

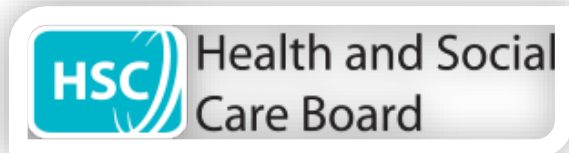
