- We are an Independent Panel appointed by the Executive Office to find out the truth about Mother and Baby Institutions, Magdalene Laundries and Workhouses in Northern Ireland from 1922 - 1995, and their related pathways and practices, including the adoption and care systems.
- We wish to hear from people who have been impacted by or who have any knowledge or memories of the institutions and their related pathways and practices.

Why share your experience with us?

- Talk to us in a safe and supportive space, with confidentiality as an option.
- Have your experience on record.
- Shape our final report and recommendations to the Public Inquiry.

Who we would like to hear from

- Any person who has been directly impacted by Mother and Baby Institutions, Magdelene Laundries and Workhouses in Northern Ireland between 1922 and 1995.
- Any person who has been directly impacted by the pathways and practices related to one of these institutions, including;
 - the care system, fostering and adoption practices,
 - related institutions such as 'baby homes'.
 - private nursing homes, and
 - cross-border and international transfers of women and children.
- Any family member of a person who has been directly impacted.
- Any person who has worked or volunteered in, or lived in close proximity to the institutions who can share any relevant information, knowledge or memories about their practices.
